5. Competition duration:		
<p>The competition duration is 2 days plus 1 additional day for International Classification prior to the start of the competition.</p>		
6. International Classification:		
<p>International Classification will be conducted on 20 September. Detailed classification schedule will follow after the revision of the final entries by WPDS Office. All athletes to be classified must arrive on time prior to the classification process start and have with them the Sport Medical Information form (available on the World Para Dance Sport website https://www.paralympic.org/dance-sport/downloads on the downloads and forms section), plus the wheelchair used during competition and straps, if any.</p>		
7. Final Entry Deadline:		
<p>5 August 2019 is the deadline for Final Entries by name, provisions of details per person and photographs for accreditation. Deadline to pay the full registration fee and accommodation (please refer to item 13).</p> <p>Please be informed that 45 days are required for eVisa.</p>		
8. Liability:		
<p>Insurance - Each National Federation and/or National Paralympic Committee is responsible for the appropriate insurance for accidents, health, property and liability of their team.</p>		
9. Eligibility:		
<p>Dance couple must consist of a male and a female partner. All wheelchair users must fulfil minimum disability criteria. Couples' entries must be submitted by their National Paralympic Committees or authorized Federation by the NPC.</p>		
10.Results:		
<p>Only athletes who have been licensed by WPDS (including partners) will be taken in consideration for inclusion in the Sport World Ranking List. Licensing process available at https://www.paralympic.org/dance-sport/downloads</p>		
11.Ranking:		
<p>The minimum number of participating countries per event must be 3. In the case lower number than 3, the couples can participate but no ranking points will be considered for the Sport World Ranking List.</p>		
12. Entries and Registration Process:		
<p>All entered athletes in the International competition (approved by WPDS) must be registered by World Para Dance Sport by the final entries' deadlines. Athletes' entries not meeting this criterion may be rejected by World</p>		

Para Dance Sport.

All athletes must be entered by their respective NPCs or authorised organizations by the NPC and accepted by World Para Dance Sport.

Couples must sign the "Amateur Declaration Statement" in the competition entry form.

For World Para Dance Sport international approved competitions there is no limit in the number of couples per NPC per event per class.

Late entries: WPDS Office must be informed about every late entry. All respective information must be reviewed on the 'case by case' basis and the entry may be accepted/ rejected by the WPDS Office. LOCs are not obliged to provide accommodation and transport in case of late entries.

Replacements: WPDS Office must be informed about every replacement. Replacements of athletes may be accepted due to injury or medical reasons. All respective medical information regarding the athlete who is to be replaced must be sent to WPDS Office by the respective NPC for further consideration regarding its acceptance/rejection.

All the registration process for the competition is as follows:

5 August 2019: deadline for Final Entry by Name and provisions of details per persons and photographs for accreditation. Deadline to pay the full registration.

13. Entry Fee and Accommodation:

1. Fee applies to everyone in the team (team leaders, coaches, athletes and accompanying person)
2. 40 EUR per person if arriving at Kaohsiung International Airport or Taichung International Airport. 80 EUR per person if arriving at Taoyuan International Airport. Fee covers Entry fee, insurance fee during stay in Taiwan and transportation fee among airport, hotel and venue, arrival and departure.
3. 35 EUR per person per day – accommodation (one room for two people) plus breakfast in the hotel, lunch and dinner at the venue (Food has a selection of Chinese style, hamburger or pizza) and farewell party.
4. All application forms, transportation and accommodation, please send form and confirmation before 5 August.

The competition will be conducted under the World Para Dance Sport Rules and Regulations and World Para Dance Sport Classification Rules and Regulations.

21. Music

Athletes competing in Freestyle/ Showdance must submit their music either by email to the LOC or on memory stick in one of widely used formats (WAV, MP3, OGG, ACC, FLAC) until **5 August 2019**
